Mint will be the exclusive payments partner across CVFR's network and intends to launch further innovative payment initiatives throughout the partnership term to enhance customer convenience. By utilising the Mint-CVFR co-branded solution, travel agents will benefit from increased cost efficiencies through automation, alternative payment options with more competitive pricing structures, and premier customer service support.

CVFR CEO & Group Managing Director, Ram Chhabra said:

"For CVFR Payments this will be a whole new business division for the group. CVFR Payments won't be just offering this solution to the CVFR Consolidation travel agents but to any agent, hotel, wholesaler, tourist attraction or any other business in the travel and tourism sector.
