

## **ZENITH SHAREHOLDERS APPROVE SCHEME OF ARRANGEMENT**

### **Key points**

- Zenith shareholders today approved, by the requisite majorities, the proposed acquisition of Zenith by Elemental Infrastructure BidCo Pty Ltd by way of scheme of arrangement ('Scheme').
- Zenith will now apply to the Court for approval of the Scheme at a hearing scheduled for Thursday, 6 August 2020.
- If the Court approves the Scheme, Zenith proposes to lodge the order of the Court with the Australian Securities and Investments Commission on Friday, 7 August 2020, at which time the Scheme will become legally effective.

### **Voting Results of Scheme Meetings**

Zenith Energy Limited (ASX: ZEN) ('Zenith') is pleased to announce that Zenith shareholders have today approved, by the requisite majorities, the Scheme.

In accordance with Listing Rule 3.13.2 and section 251AA of the *Corporations Act 2001* (Cth), a detailed report of the votes cast in respect of the resolutions to amend and approve the Scheme is included at **Annexure A** to this announcement.

### **Notice of Second Court Hearing**

Implementation of the Scheme remains subject to approval by the Supreme Court of Western Australia ('Court'), and the satisfaction or, where capable, waiver of certain other customary conditions as set out in the Amended and Restated Scheme Implementation Deed released to the ASX on 21 July 2020 and as described in the Scheme Booklet and Supplementary Scheme Booklet prepared in connection with the Scheme available at: <https://www.zenithenergyltd.com/investor-centre/scheme-of-arrangement>.

Zenith has applied to the Court for approval of the Scheme at a hearing scheduled for Thursday, 6 August 2020.

Further details regarding the Court hearing are included at **Annexure B** to this announcement.

### **Next Steps**

If the Court approves the Scheme, Zenith proposes to lodge the order of the Court with the Australian Securities and Investments Commission on Friday, 7 August 2020, at which time the Scheme will become legally effective. This will be the last day that Zenith shares will trade on ASX.
