

ASX Release | ClearVue Technologies Limited (ASX: CPV)**Issue of Placement Shares and Cleansing Notice**

Further to the ASX announcement on 14 August 2020, ClearVue Technologies Limited (ASX:CPV) (**ClearVue** or the **Company**) has today issued 26,973,260 fully paid ordinary shares at \$0.095 each to professional and sophisticated investors.
