Completion of Share Purchase Plan

Pantoro Limited (**ASX:PNR**) (**Pantoro**) is pleased to advise that the share purchase plan announced on 7 August 2020 has now been completed.

Pantoro has issued a total of 22,916,967 shares to applicants at an issue price of \$0.24 to raise approximately \$5,500,000.

Refunds for scaled back applications (as well as late and invalid applications) are expected to be made from 3 September 2020.

Pantoro Limited (ACN 003 207 467) (ASX: PNR (**Company**)) gives this notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (the **Act**).
