Paradigm Biopharmaceuticals Limited ACN 169 346 963 (ASX: PAR) Cleansing Notice under section 708A of the Corporations Act 2001 (Cth)

On 10 September 2020, Paradigm Biopharmaceuticals Limited ACN 169 346 963 (**Company**) issued 75,000 fully paid ordinary shares in the Company by exercising 75,000 options at an exercise price of \$0.65 per option expiring 18 May 2021. On 14 September 2020, the Company issued 35,000 fully paid ordinary shares in the Company by exercising 35,000 options at an exercise price of \$0.312 per option expiring 15 November 2020.
