## **Praemium's intention to undertake compulsory acquisition of Powerwrap**

Praemium Limited ("**Praemium**") refers to its recommended off-market takeover offer for all the issued shares of Powerwrap Limited ("**Powerwrap**") (the "**Offer**"), as set out in Praemium's Bidder's Statement dated 22 July 2020, as supplemented by the First Supplementary Bidder's Statement dated 14 August 2020, the Second Supplementary Bidder's Statement dated 28 August 2020 and the Third Supplementary Bidder's Statement dated 14 September 2020 (together, the "**Bidder's Statement**").

Capitalised terms which are not defined in this announcement have the meaning given to them in the Bidder's Statement.

### **Praemium's intention to undertake Compulsory Acquisition**

The Offer is scheduled to close today at 7:00pm (Melbourne time). As at the date of this announcement, Praemium has a relevant interest in 92.31% of Powerwrap Shares. As Praemium has a relevant interest in more than 90% of Powerwrap Shares, it intends to compulsorily acquire the outstanding Powerwrap Shares on issue, on the same terms as the Offer.

Compulsory acquisition notices will be dispatched to all Powerwrap Shareholders tomorrow who have not accepted the Offer by the close of the Offer Period today. A copy of the compulsory acquisition notice will be lodged with ASIC tomorrow.
