## **Purchase of shares in VGI Partners Asian Investments Limited (ASX:VG8)**

On 6 October 2020, VGI Partners Limited ("VGI Partners") (ASX:VGI) purchased 10,000 shares in VG8 (the "Shares") to hold on its own balance sheet taking VGI's total holding in VG8 to 10,861,123 ordinary shares.
