Key areas of activity during the first quarter of the 2021 financial year were:

- **GoGetta operations**

The GoGetta business continued to operate profitably during the first quarter of the year and produced positive operating cash flows. The business added seven contracts for five existing clients to the value of \$420,000.

- **SIV Capital on-going**
