No amounts are payable under these facilities, other than the annual fee, unless the consolidated entity does not adhere to the terms of the agreements guaranteed.</p> <p>On 17 September 2020, the Company announced it had received Credit approved terms sheet from two Tier-1 international banks, BNP Paribas and Société Générale (Financiers) for A\$55 million. The financiers had been formally mandated with next steps including legal due diligence, documentation and completion of conditions precedent prior to first drawdown.</p>
