The loan is on commercial arm's length terms and is repayable on demand after 45 days.</p> <p>On 4 September 2020, the Company announced a Conditional Asset Sale Agreement with IGO/Newsearch whereby the Company grants IGO exclusive rights to explore for minerals within its 9 exploration licences. The terms include a \$5.5 million upfront cash consideration and a \$250,000 loan, payment for which will be deducted from the upfront cash.</p>
