The Board of Transcendence Technologies Limited (**TTL** or the **Company**) provides the following report on its activities for the quarter ended 30 September 2020.

The Company remains suspended from official quotation in accordance with Listing Rule 17.3, after ASX determined that TTL's operations are not adequate to warrant the continued quotation of its securities pursuant to ASX Listing Rule 12.1. The suspension will continue until the Company is able to demonstrate compliance with Listing Rule 12.1.

The Board continues to proactively identify and review acquisition and investment opportunities, while conserving cash.

At the end of the quarter, the Company had cash reserves of approximately \$0.68 million. The Appendix 4C report attached to this report contains the Company's cash flow statement for the quarter.
