Answer: No, because the Company has completed most of its drilling programme for the year in the current quarter. Expenditures are expected to be substantially lower in the next two quarters.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: No. As stated above, the Company will not have the same level of expenditure in the coming quarters, as the 2020 drilling program was substantially completed in the September 2020 quarter. Expenditure in coming quarters is expected to significantly drop as a result. In addition, the Company has 106.5 million share options outstanding, exercisable at a price of \$0.20, for an amount of \$21.5M. These options are currently in the money and are exercisable by end March 2021

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. Now that the 2020 drilling program is complete, drilling and explorations activities will be minimal. The Company has sufficient cash reserves for its planned expenditures.
