	Answer: No. Cash outflows during the September 2020 quarter were abnormally high following the Company's capital raising and reinstatement to trading on the ASX during the June 2020 quarter.

	Answer: Yes. Following discussions with major shareholders, the Company is confident that significant short-term funding will be derived from the conversion of unlisted options exercised at \$0.03. If all options in this class were exercised, funds raised would be approximately \$1.5m.
