
Love Group reports first quarter FY21 results

- Quarterly customer cash receipts of \$799k and net operating cash flow of \$40k
 - Quarterly customer cash receipts of \$799k, up 28% quarter-on-quarter and down 21% year-on-year
 - Quarterly net operating cash flow of \$40k
 - Ending quarterly cash balance of \$1,545k, an increase of \$34k quarter-on-quarter
- Increase in matchmaking customer cash receipts quarter-on-quarter
 - **Hong Kong:** \$584k customer cash receipts for the quarter, versus \$513k in the previous quarter, up 14% quarter-on-quarter, primarily due to increased consultation volume
 - **Singapore:** \$200k customer cash receipts for the quarter, versus \$77k in the previous quarter, up 158% quarter-on-quarter, primarily due to increased consultation volume
 - **Bangkok:** \$10k customer cash receipts for the quarter, versus \$23k in the previous quarter, down 85% quarter-on-quarter, primarily due to lower consultation volume
 - **London:** \$6k customer cash receipts for the quarter, versus \$9k in the previous quarter, down 34% quarter-on-quarter, due to decrease in online dating revenues

Love Group Ltd (ASX:LVE) is pleased to present its quarterly cash flow report and operational update for the quarter ending September 2020.

Love Group Founder and CEO, Michael Ye: "Our business rebounded in the first quarter of fiscal year 2021, driven by lifting of COVID-19 restrictions in our key markets of Hong Kong and Singapore. We increased back our marketing budget and staffing levels in response to drive higher consultation and sales volume to deliver our second straight cash flow profitable quarter with operating cash flow of \$40k.

Looking ahead, we will continue to manage our business in a cautious and prudent manner as a result of the ongoing COVID-19 pandemic, and will manage our operating expenses to be in line with our sales levels to maintain our balance sheet strength and liquidity."
