Non-Executive Director Mr Zhang Chi is the Managing Director of Sinom (Hong Kong) Limited. In April 2020, Sinom assigned these loans to Regency Mines plc. Loans are unsecured and interest free with a maturity date of 31 March 2021. Regency have confirmed that it will not request repayment of these loans for a period of 12 months from the date RMI's directors sign RMI's June 2020 annual financial statements (subject to certain conditions, such as not appointing an administrator and not paying dividends).</p> <p>Sinom have continued providing unsecured interest-free advances in excess of the \$1.71 million facilities above.</p>
