**Quarterly Activity Report for the Period 1 July 2020 – 30 September 2020****Operations**

During the quarter ended 30 September 2020 Stream Group Ltd (“Stream”) continued to provide insurance claims management software to claims management companies and to progress the upgrading of BuildAssist, the Company’s core software product. Revenues remained subdued due to the low volume of insurance claims in New Zealand, our principal market.

**Proposed Acquisition of Mayfield Group Investments Pty Ltd**

At the shareholders meeting held on 23<sup>rd</sup> October 2020, shareholders approved the various resolutions required to implement the proposed acquisition of Mayfield Group Investments Pty Ltd (“Mayfield”). Mayfield is a well-established, profitable group of companies that supply electrical products and services to the electrical infrastructure industry throughout Australia. Directors believe that there are some interesting opportunities for Mayfield as the electrical infrastructure industry undergoes profound change over the next few decades, both as a result of the swing from fossil fuel to renewables sourced energy and from the acknowledged need for a major upgrade to the national electricity transmission and distribution networks.
