Appendix 4C – Quarterly cash flow report

Aquis Entertainment Limited ACN 147 411 881 (**Aquis** or the **Company**) (ASX: AQS) attaches the Appendix 4C Quarterly cash flow report for the quarter 1 July 2020 to 30 September 2020.

Business activities

Aquis' ordinary business activities are the operation of Casino Canberra, incorporating Natural Nine restaurant.

On 10 August 2020, Casino Canberra was allowed to re-commence trading under Covid-19 restrictions after being directed by the Government to shut down its operations from noon 23 March 2020 as part of the measures to slow down the spread of Covid-19.

Measures to ensure compliance with the Government's trading restrictions was implemented prior to the reopening of the casino; review and updates to these measures is ongoing to ensure full compliance with the restrictions in place on a day to day basis. Since re-commencement of trading, while visitation levels are down due to capacity restrictions, business revenues are strong and net operating cash flow for the quarter is positive.

All stood down employees were initially recalled to work at reduced hours based on these trading restrictions. On 9 October 2020, the ACT Government announced a further easing of restrictions, increasing capacity from 100 to 200, in conjunction with the 1 in 4 square metre rule. As a result, the majority of employees have now been recalled to their original working hours.

Expenditure

Total expenditure during the quarter on business activities totalled \$3.497m which includes \$2.681m in payroll expenses and \$0.816m in other operating expenses.

Government grants and tax incentives received, representing JobKeeper wage subsidy reimbursements and Cash Flow Boost from the Australian Federal Government, totalled 1.427m.

Related party transactions

Total payments made to related parties included in the above expenditure, during the quarter was \$120,000.

This expenditure was made to non-executive director's fees to Mr Alex Chow, Mr Russell Shields (JobKeeper subsidised) and CEO/executive director's salary to Ms Allison Gallaugher (JobKeeper subsidised). No other related party transactions occurred during the quarter.
