As announced on 11th December 2019 the terms of the convertible notes issued to JHY provided that the notes would mature on 31 December 2019 and that an interest rate of 16% per annum would be payable on the notes. The Company negotiated an extension of the maturity date for the notes for a further year and a lower interest rate. The maturity date for the notes is now 31 December 2020 and the interest rate payable on the notes reduced to 10%. During this quarter \$2,000,000 was repaid with cash.</p>
