Answer: Operational expenditures for the forthcoming quarter are expected to be \$35,000; development expenditure for the forthcoming quarter are expected to be \$15,000; therefore, estimate net cash used in operating activities for the December quarter to be \$50,000.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: On the 8th and 19th October 2020, loans amounting to \$100,000 were entered into with EMMCO Sdn. Bhd. (a Malaysian incorporated company) to fund ongoing company operations and to continue laboratory test work on the Cattle Creek drill samples. The Company Directors remain committed to sourcing further funding for the future.

Answer: An information memorandum will be prepared, with explanatory competent person assessment/report, as support documentation to raise new capital. Currently this process awaits results from metallurgical test work based on samples from the latest drilling programme.
