During the quarter ended 30 September 2020, YPB repaid \$600,000 of the short-term loan to the Chairman by issuing 600,000,000 shares at \$0.001 per share in accordance with the resolution approved at the AGM on 22 July 2020, and settled the outstanding interest accrued on this principal amount of \$17,924 by cash.
