WestStar Industrial Limited September 2020 Quarterly Report

WestStar Industrial Limited (Company or **WestStar)** (ASX: WSI), an Australian industrial services company, operating in the energy, resources, utility and infrastructure sectors, in metropolitan and remote areas, across Australia, is pleased to report on the Company's performance for the quarter ended 30 September 2020 (Quarter).

Highlights

- Cash receipts of \$15.9M up from \$12.2M in the June quarter.
- Operating receipts significantly higher than operating payments resulting in an operating Net Cash improvement of circa \$2.0M for the Quarter.
- Cash balance increase from June quarter of \$6.6M to \$8.42M, an increase of \$1.8M.
- WestStar subsidiaries (the Group) continue to deliver another profitable quarter.
- Awarded Contracts for the quarter totalling \$15M.
- The Group is well positioned for a strong Q2 FY21 with Tendering activities expected to deliver further rewards and strengthened Pipeline of projects for the group.

Company Financial Overview

WestStar's objective to deliver sustainable growth and profitability has delivered another positive quarter.

During the Quarter, the Company banked total cash receipts of \$15.9M, continuing from its strong FY2020 performance.

Operating receipts for Q1 FY2021 were significantly higher than operating payments, increasing net operating cash by \$1.8M for the Quarter. This result follows on from \$12.2M banked in June quarter representing a 30% increase for the period.

The Group has maintained its run rate during the first quarter of FY2021 to deliver receipts commensurate with its growth trajectory. The result was well contributed to by both Alltype Engineering and SIMPEC.

This positive September quarterly continues to reflect WestStar's focused and responsible growth trajectory and ability to manage its cash reserves effectively.

Group Initiatives and Strategies.

The Company set out to achieve a range of initiatives in its strategic planning to become more streamlined, sophisticated, and cost-efficient in its approach to FY2021. The Company is now experiencing the rewards of these initiatives with both companies operating competitively.

The Company continues to optimise shared resources across the group and continues to position itself in a market that can maintain a cost competitive advantage. Administrative staffing and corporate costs during the Quarter continue to be analysed to provide leverage to further earnings growth.



Interstate Growth

WestStar continued to grow its successful operational footprint into NSW through SIMPEC and is hopeful of further contract extensions at the Sydney WestConnex New M5 Project with the CPB Dragados Samsung JV to be forthcoming.

With this presence, Tendering activity has increased opportunities now in both NSW and QLD as WestStar continues to support and encourage growth for both SIMPEC and Alltype Engineering in both these regions. Both companies are now leveraging the opportunities that are being presented to its collection of services and wider group offering.

The Company maintains its flexibility and workplace systems to adapt to the changing environment moving into the future with adaptive strategies ready to deploy should the necessity arise.

Alltype Engineering Operations

Alltype Engineering continued to execute work in hand and secure significant new orders and additional backlog, trending toward setting a new company revenue record. Some key achievements were:

- Securing major structural steel and modularisation package for the Rio Tinto Koodaideri iron ore mine development
- Securing call off and ongoing maintenance contract on a petrochemical processing facility
- Securing fabrication and construction of a turnkey multidiscipline gas metering facility in the Mid-West
- Final delivery of the last Smartway Freeway gantry sign on Manning Road, Perth.
- Practical completion of a gas compressor station / gas processing facility which is now commercially operational
- Main Roads utility relocation works continued on bridge and Metronet road modification projects
- Delivery of a major process piping fabrication package for the FMG Whims Project at Christmas Creek

Alltype Engineering continues to tender an increasing range of works across multiple industries, with current travel restrictions and border constraints continuing to drive an increase in local fabrication opportunities and service demands, particularly in the resources sector. Furthermore, Alltype Engineering's growing reputation as a Tier Two construction contractor has opened up national project opportunities in both prequalification and tendering phases within the oil and gas sector.

SIMPEC Operations

SIMPEC continued to execute existing contracts and also performing a number of new tender submissions for new and existing clients. The Quarter highlights include:

- Sydney WestConnex New M5 Project with the CPB Dragados Samsung JV Sydney M5 Project team performing commissioning activities safely on site with zero injuries..
- Continuation of the FMG Power station project.
- Continuation of the Rio Tinto RDSS project.
- Engagement of our first indigenous JV tender submission delivering Infrastructure and operational services to the resource sector.

Tendering and proposals for the quarter was at record levels. Several of the submissions were for new clients within the mining and infrastructure sectors, the results of which are expected to deliver positive outcomes for the business in the near term.



Outlook

The Company tendered a record ~ \$300M of new live project opportunities during the quarter.

Individual High Value project opportunities are now being offered to both Alltype Engineering and SIMPEC. The group's ability to execute larger contracts was only previously constrained by working capital, we now enter a mature phase of the strategic cycle to demand larger scale projects.

Commenting on WestStar Industrial Outlook for the Quarter, WestStar Industrial Chief Executive Officer, Robert Spadanuda noted:

"During the first quarter of FY2021, we continued to demonstrate the ability to grow revenue along with resourceful opportunity in the following key areas:

- Developed and Increasing Opportunity Pipeline of ~\$300M in recently tendered live projects.
- \$15M of contract wins announced since 1 July 2020.
- Further imminent / near-term contract wins expected with enquiries operating at high demand.
- Larger Individual Contract Value submission and Exposure to key Mining and Infrastructure projects.
- Market segment exposure growth to Iron Ore, Oil and Gas, Power Generation, Water, Waste Processing and Transport Infrastructure projects.
- Positive exposure to recent Government stimulus programs in Infrastructure Construction, Oil and Gas and Power Generation.
- Continual review of Selective strategic acquisition opportunities to complement capability and Geographical footprint."

Commenting further, Mr Spadanuda also noted:

"We continue to grow a solid business and a strong reputational brand. Increased activity in a variety of Government stimulus programs provides further confidence in our ability to grow at a rate commensurate with our growth trajectory. WestStar Industrial is on an exciting journey and we thank all Management, staff and shareholders for their continued support."

With an ever-increasing landscape of significant opportunities, WestStar expects the outcomes of tendering activities and current project opportunities to deliver positive results in Q2 FY2021. These opportunities will significantly accelerate the group towards increased revenues and earnings for its shareholders. We look forward to updating the market upon execution of some of these opportunities.
