8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: PNX informed the market that a Non-binding Term Sheet has been agreed with private company Halifax Capital and a joint venture (JV) with its subsidiary Bridge Creek Mining, including a proposed financial commitment of A\$40m to develop the Fountain Head Gold Project (see ASX release dated 15 July 2020). A formal agreement is expected to be completed by 16 November 2020 (see ASX release dated 9 October 2020). Further planned exploration activity is dependent on the anticipated capital raising outlined below in 8.8.2.	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: The Company intends to raise further capital to fund its continuing operations during the second quarter. Historically, the Company has been able to raise funds and receives strong support from its shareholders. Accordingly, the Company expects to be able to raise the required funds.
