September 2020 Quarterly Shareholder Update and Appendix 4C

Key highlights:

- The Company has issued the Tranche 2 Placement shares on 2 July 2020 raising a total of \$106k following shareholder approval at a general meeting on 3 June 2020.
- The Company has also issued 2,702,703 options exercisable at \$0.0001 expiring 1 January 2022, in lieu of 6 months (January 2020 to July 2020) cash payment of salary (\$100,000) to Mr Kotti pursuant to his remuneration arrangements announced on 6 January 2020. Shareholder approval for this issue was obtained on 3 June 2020.
- There were no substantive business activities during the quarter. The Company remain
 focused on building commercial proof-points for its existing technology with partners and
 customers. Concurrently, the Company is also reviewing possible mergers and acquisitions
 with IT companies which will be complementary to Gooroo's existing technology, experience
 and customer base.

Related Party Payments:

During the quarter, the Company made payments of \$15k to related parties and their associates for administrative and operational requirements during the period.

Mr Richard Symon has agreed to reduce his director fees from 1 July 2020 from \$3,333 per month to \$2,000 per month, with the balance subject to shareholder approval to convert into ordinary shares at the next available general meeting. Mr Tom Brown has agreed to reduce his director fees from 1 July 2020 from \$6,000 per month to \$3,000 per month, with the balance subject to shareholder approval to convert into ordinary shares at the next available general meeting.
