As set out in the ASX announcement of 14 August 2020, Lucapa concluded facility refinancing discussions during the Quarter and agreed terms with its major financiers and shareholders with respect to amending the principal repayment terms and finance charges, the net effect of which defers ~US\$13.0m in loan repayments from 2020 & 2021 to 2022 and beyond.

1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

No. The Mothae mine remained on care and maintenance for the Quarter as a result of the COVID pandemic which required operations to stop in late March 2020. As per the ASX announcement dated 8 October 2020, the Mothae mine has now resumed operations and the Company expects this, together with the improving diamond market, to result in better operating cash flows. In addition, and as per the ASX announcement dated 9 September 2020, the Company has investigated solutions and plans to expand the processing capacity at Mothae that should see a material increase in returns from the mine for all stakeholders following implementation. The Company will update the market on the expansion plan in due course.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

The Company has investigated a number of funding alternatives for the Mothae expansion plan and believes the funding will be successfully secured.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:
