# Appendix 4C Quarterly Cash Flow and Quarterly Activity Report (QAR)

Australian Dairy Nutritionals Limited (AHF or the Group) advises that this activity report relates to the Appendix 4C for the quarter ended 30 September 2020 (**Quarter**) released to the market on 30 October 2020.

# **Details of the Company's Business Activities for the Quarter**

The Group's business activities during the Quarter focussed on dairy farming and dairy manufacturing. Construction of the building to house the Group's infant formula plant, as announced to the market on 19 June 2020, also continued throughout this quarter and is progressing well.

The farm segment performed very well during the Quarter exceeding budgeted revenue and gross profit, particularly in the month of September; assisted by favourable seasonal conditions. The processing segment incurred additional expenditure on raw materials and packaging in preparation for range changes in October/November 2020.

The Expenditure reported in the Quarter relates primarily to:

- · dairy operating costs including feed and labour;
- dairy manufacturing costs including raw materials, packaging, logistics and labour;
- payments in relation to the construction of the new manufacturing facility;
- employment costs; and
- corporate costs including ASX fees, registry fees, consulting and advisory fees.

# Payments to an associate of, a related party of the Company (section 6 of Appendix 4C)

Section 6 of the Appendix 4C includes details of the following fees paid to associates or related parties of the Group:

- \$176,000 in fees and salaries paid to Directors of the Group;
- \$5,000 paid to Australian Adventure Tourism Pty Ltd (AAT) for administrative services comprising book keeping and accountancy fees (charged at cost). AAT is a related party of AHF as the Group's non-executive director Michael Hackett is a substantial shareholder of AAT.
