- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

The net operating cash flows are still impacted by the commodity prices (Gas, Oil & LPG) as a result of COVID-19, however, they are starting to rise again. The cash generating ability of the Kincora Project will continue to increase as the Group's 2020 work program progresses.

In addition, the Company is continuing its cost reduction initiatives including the reduction of salaries and fees, payments in shares, minimisation of field expenditures and administration costs and overheads.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

Armour has a further \$2.6 million to be received from the recently announced \$15 million capital raise, subject to shareholder approval at the AGM. On 28 October 2020, Armour announced the commencement of a stimulation program that should increase production over November 2020. Additionally, Armour has appointed Ocean Reach Advisory to assist with the Farm-in of the NT acreage and the potential farm-out of the South Nicholson Basin.

The Company has the ability to manage capital and liquidity by taking some or all of the following further actions:

- Raising additional capital or securing other forms of financing, as and when necessary to meet the levels of expenditure required to meet the Group's working capital requirements.
- Reducing its level of capital expenditure through farm-outs and/or joint ventures.
- Managing its working capital expenditure.
- Applying for eligible Research and Development tax refund receipts, and other Government incentives; and
- Disposing of non-core assets.

- Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes, on the basis that the current capital raise, increase in production from the stimulation program and asset transactions, to which Ocean Reach Advisory have been appointed to assist, along with the other cost reduction initiatives, will enable the Company to undertake a modest 2020 work program, fund its operations and meet its business objectives.
