### **Appendix 4C monthly and quarterly cash flow report and business update – September 2020**

Smiles Inclusive Limited (ASX: SIL) today releases its Appendix 4C cash flow report for the month and quarter ended 30 September 2020.

Receipts from customers for the month were \$2.3 million and \$7.2 million for the quarter. Whilst the impact of COVID-19 remains (including the forced closures of Victorian practices) cash receipts were \$3.2 million higher than the previous quarter, showing a pleasing return to more positive trading conditions.

In addition to cash receipts from customers, the Company received \$869k for the month from the Australian Federal Government's JobKeeper incentive program, bringing total JobKeeper receipts to \$2.2 million for the quarter.

Cash payments for the month relating to operating activities were \$2.7 million and included approximately \$220k of one-off expenses for capital raising costs, statutory compliance and EGM related expenditure. Total operating cash payments were \$9.4 million for the quarter, including \$71k paid to Directors of the Company.

The Directors note that the positive operating cash flow result for the month of \$460k (and \$58k net cash operating outflow for the quarter) included a high proportion of catch up payments which resulted in trade creditors reducing by approximately \$800k. Interest payments have been deferred with the approval of the Company's financiers.

In addition, the Company raised \$229k of funds through a placement of shares at \$0.025 per share. A further \$28k was raised at the start of October 2020, resulting in the issue of 10,271,000 ordinary shares.

The Company continues to progress the capital raising and refinancing arrangements with NAB and will provide a further update shortly.

(a) Balances are inclusive of interest (3.09% at the end of the period) and other charges incurred that have been capitalised on the Senior debt facility and Working capital facility. As advised to the market and shareholders, the Group has entered into negotiations with potential financiers and is in final stages to provide funding to repay existing facilities and raise additional working capital. In accordance with the security arrangements of the facilities, all current and non-current assets of the Group are secured by floating charge except as identified below. The Senior debt facility has a maturity date of 31 March 2023 and the Working capital facility has a maturity date of 31 August 2020. The credit card facility is rolling facility.

(b) The Group has secured an equipment leasing facility to assist with the financing of key items of capital expenditure. In accordance with the security arrangements of the equipment lease facility, specific non-current property plant and equipment items are secured against the facility. The master agreement has a five year term ending 1 October 2023.

(c) The Group has received four unsecured loans from four separate parties, which comprise:

- \$700,000 representing funds to assist with the Group's turnaround plan, at an interest rate of 9.95% per annum and is repayable upon agreement between the Group and the lender at any time after 31 January 2020;
- \$585,000 representing retained funds due to the joint venture partner following the sale of the Gatton and Laidley practices in December 2019, at an interest rate of 0% per annum and at call;
- \$200,000 provided for working capital purposes to assist the Group to implement its turnaround plan, \$100,000 of which is at an interest rate of 10% per annum with the remaining \$100,000 interest free and at call. The loan was reduced by \$2,500 during the month.
- \$100,000 provided for working capital purposes to assist the Group at an interest rate of 10% per annum and a repayment date upon agreement between Smiles and the lender any time after 27 July 2020.
