On 1 September 2020, the Company announced that contingent on the completion of the acquisition of 100% of Piccadilly Gold Mine Holdings Pty Ltd it had agreed with its financier Aquis Finance Pty Ltd to increase the current loan facility by providing an additional \$500,000 to assist funding current operations. Aquis Finance had previously requested that a variation document be completed to allow for them to convert the debt to equity in the company at \$0.02 per share.</p> <p>The \$157,500 loan comprises a short-term facility from a sophisticated investor. During the quarter \$100,000 of the facility was repaid. The remaining facility was repayable on 13 January 2020 but has been extended by mutual consent.</p> |   |   |  |
