<p>Aus Tin Mining Ltd entered into a Convertible Security Funding Agreement (CFSA) with The Australian Special Opportunity Fund LP for an aggregate of \$3.5 million that had a face value of \$4.2 million. The Convertible Notes issued under the CFSA are secured by a General Security Agreement over the Company and guarantee and indemnities from its wholly owned subsidiaries. Since the series of drawdowns, the CFSA has been partially repaid via the allotment of shares. As at 30 September 2020, the balance outstanding on the facility was \$2.15 million.</p> <p>On 31 July 2020 Aus Tin Mining Ltd appointed Bizzell Capital Partners Pty Ltd (<b>BCP</b>) as Lead Manager for an issue of convertible notes. BCP <u>may</u> procure a up to \$550,000 in face value to provide general working capital and finance the costs of the Rights Issue (<b>BCP Facility</b>). To date the Company has drawn \$300,000 under the BCP Facility.</p>

8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No, the Company had previously announced the proposed sale of the Granville Tin Mine and are pursuing alternative options for divestment. In the interim the project remains on care & maintenance incurring significantly lower costs than when operating.

From 1 March 2020, the Board and Management of the Company agreed to a 25% reduction of their remuneration through to 30 September, and continue to accrue the balance to be met by way of share issue from time to time as part of the Company's strategy to preserve its treasury. Administrative fees for back-office management also continue to be accrued.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company has previously announced a proposed Rights Issue to raise a up to \$3.0 million and the Offer closes at 5pm AEST on 30<sup>th</sup> October 2020. An update on the Rights Issue will be provided the first week of November. Furthermore, the Company has announced an issue of convertible notes to provide general working capital and finance the costs of the Rights Issue. Written commitments for the partial placement of any shortfall arising under the entitlement offer have also been received by the Company.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, for the reasons outlined in Questions 1 and 2, the Company expects to have further working capital via the announced Convertible Note placement and the rights issue, sufficient to continue to fund its operations and meet its business objectives.
