The balance at the end of the quarter was \$nil.</p> <p>¹ The short-term loan facility (of up to \$2m) is repayable to Laneway by 30 November 2020. Interest receivable on the funds advanced is at 8% per annum. The loan has been advanced to BAM Opportunities Fund Pty Ltd and enables Laneway to be able to generate an enhanced return on surplus cash held and is secured by a first ranking fixed and floating charge over the assets of the borrower. Subsequent to the end of the quarter, a further \$155,000 has been repaid to Laneway.</p>
