### Answer:

No. Due to recent business development activities, including the acquisition of the Broadmeadow East coking coal project, the Company has incurred significant additional costs for technical studies and analysis and (legal and financial) due diligence. While the Company expects to continue actively assessing business development opportunities, the recent work (and costs) were higher than normal.

#### Answer:

On 2 November 2020, the Company announced that it had binding commitments for a Placement of \$3.0m. The Placement is expected to be completed by 9 November 2020.
