Family Zone Cyber Safety Ltd (ASX: FZO, **Family Zone** or the **Company**), supporting and protecting every child's digital journey, advises that:

- 680,680 Shares have been issued to Netsweeper Netherlands Cooperatief U.A pursuant to the Collaboration Agreement with the Company, entered into in May 2018, for the provision of internet content filtering services to Family Zone. These Shares are being issued under the Company's Listing Rule 7.1 capacity;
- 500,000 Shares have been issued following the exercise of 500,000 Options (\$0.18, 13 July 2023) raising \$90,000; and
