As part of the refinement of 360 Capital REIT's (the "Fund" or "TOT") strategy, TOT notes Velocity Property Group's (Velocity or ASX:VP7) announcement today that it will hold an Extraordinary General Meeting on 17 February 2021 to allow shareholders to vote on 360 Capital Group's (ASX:TGP) proposal to restructure VP7 into a real estate debt business (the "Proposal"). The Proposal includes, amongst other things, the acquisition (subject to VP7 shareholder approval) of AMF Finance Pty Limited ("AMF") for \$3 million.

TOT will also sell its equity interest in VP7 to TGP and is also expecting to be repaid its convertible note as part of the Proposal in line with TOT's real estate equity strategy.

Based on TOT's 50% ownership of AMF, TOT is expected to receive \$1.5 million for its interest which would be included in the FY21 result. The sale remains subject to the Proposal proceeding.
