- Loan facility with BDC for CAD\$1,166,142 secured by first mortgage over the group's freehold land and buildings. The facility is repayable in monthly instalments ending 15 November 2042. Interest rate is variable and is currently 4.2%.
- Contribution agreement with Atlantic Canada Opportunities Agency (ACOA), for CAD\$1,000,000. As at 31 December 2020 it has been fully drawn down and the balance outstanding is CAD\$832,816. The facility is interest free and repayable in monthly instalments.
- Loan facility through the CARES Act Paycheck Protection Program for USD\$36,706.
