**Clime Capital Limited – request for trading halt**

Pursuant to ASX Listing Rule 17.1, Clime Capital Limited ABN 99 106 282 777 (ASX: CAM) (**CAM**) requests an immediate trading halt be granted by ASX in respect of its ordinary shares from the commencement of trading on Friday, 12 February 2021.

CAM requests the trading halt pending an announcement by CAM in relation to a proposed capital raising to be conducted by CAM.

In accordance with ASX Listing Rule 17.1, CAM provides the following information:

- (a) **Reason for trading halt:** the trading halt is requested to allow the capital raising to take place in an orderly manner.
- (b) **Duration of the trading halt:** CAM requests that the trading halt remain in place until the earlier of such time as it makes an announcement to the market in relation to the outcome of the capital raising or the commencement of trading on Tuesday, 16 February 2021.
- (c) **Termination of the trading halt:** CAM anticipates that the trading halt will cease upon it announcing the outcome of the capital raising.
- (d) **No reason:** CAM is not aware of any reason why the trading halt should not be granted by ASX.
- (e) **Further information:** CAM is not aware of any further information which needs to be disclosed to the market at the time of seeking the trading halt.
