European Metals Holdings Limited ("European Metals" or "the Company") (ASX & AIM: EMH, NASDAQ: ERPNF) advises that it has completed the cancellation of 3,000,000 unlisted options (exercise price \$0.25 expiring 31 December 2022) and the issue of 2,435,880 CDIs in lieu of these options in accordance with the terms and conditions of the consultant options held by European Energy and Infrastructure Group Limited. The CDIs have been issued for nil consideration per the terms and conditions of the options and under Listing Rule 7.2 exception 9.

The Company also advises that it has issued 300,000 CDIs in satisfaction of a \$330,000 fee for the provision of digital marketing services and 1,200,000 warrants, exercise price of \$1.10 per warrant expiring on 31 January 2023, to an investor relations consultant.
