Following the ASX Announcement dated 9 March 2021, ALF shareholders voted in favour of the restructure of their investment in ALF by way of scheme of arrangement on the terms set out in the Scheme Booklet dated 2 February 2021 (Scheme).

ALF will seek orders approving the Scheme from the Federal Court of Australia on 16 March 2021. If these orders are made, the Scheme will be implemented. ALF will update shareholders following Tuesday's hearing.
