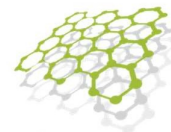
The incorporation of PureGRAPH[®] into composites improve the mechanical properties, whilst also providing an additional barrier to moisture intake and hydrolysis attack.

First Graphene reported in 2020 that initial test work had been completed using a conventional composite material and system to evaluate the performance of increasing PureGRAPH[®] 20 concentrations compared to a control system.

Results showed a significant increase of 59.4% in flexural strength for a 1% addition rate of PureGRAPH[®] 20 within the laminate. This result demonstrates the enormous potential for PureGRAPH[®] enhanced composite structures within the Marine sector, leading into Wind Turbine opportunities whereby PureGRAPH[®] could be used to extend the lifecycle of blades.

CEO, Michael Bell said "I would like to welcome Matt to the First Graphene team.
