**SYDNEY, Australia, Monday 26<sup>th</sup> April 2021:** Uscom Limited (ASX code: UCM) (the **Company** or **Uscom**) today released its Appendix 4C – Quarterly Cash flow report for the quarter ending 31 March 2021 (the **Quarter**) and Year to Date (**YTD**). The results disclosed in the attached Appendix 4C are in Australian dollars

#### Summary:

Cash receipts \$0.89m, down 53% from \$1.91m

#### Report:

The Uscom 4C for Q3 FY 2021 reports cash receipts of \$0.89m for the quarter, down 53% from \$1.91m in the preceeding quarter, and at \$4.2m YTD with Q4 trading still ahead. Sales revenue was \$0.78m down 20% from \$0.98m on the preceeding quarter. This follows record growth of cash receipts of 149% and sales revenue of 125% reported in the prior Q2 4C. For the current quarter the global entity reported a net operating cash outflow of \$0.25m, while for Q2 cash flow was positive \$0.3m. The entity remains cash flow positive for the YTD with \$2.03m cash on hand at 31<sup>st</sup> March.

#### Commentary:

Uscom Executive Chairman, Professor Rob Phillips said “Q3 sales and receipts remain strong but down due to the impact of the Chinese New Year, effecting China activity for 6 weeks, while both European and US activities remained constrained by the pandemic. Hungary has effectively been closed for the quarter and our US team are still unable to attend hospitals and clinics. However we remain cash flow positive for the YTD, supported by strong China sales. Going forward management noted the 18.3% GDP growth in China for the March quarter and look forward to this growth converting into health spending. Europe and the US have also begun tentative recoveries with healthy sales prospects starting to emerge. Additionally the Uscom BP+ has just received NMPA regulatory approval initiating an additional revenue stream for Uscom China. The SpiroSonic AIR continues its CE and FDA regulatory progress, which has also been significantly delayed due to the pandemic. These approvals, once received, are anticipated to stimulate revenue over the next 12 months, particularly as global economies resume normal medical business.”

Uscom manufactures and markets the **USCOM 1A**, the Uscom **BP+**, and the Uscom **SpiroSonic** digital ultrasonic spirometry technologies and the **VENTITEST** and **VENTITEST-S** ultrasonic ventilator calibration devices for optimising respiratory device performance.

The USCOM 1A device has major applications in Paediatrics, Emergency, Intensive Care Medicine and Anaesthesia, and is the device of choice for management of adult and paediatric sepsis, hypertension, heart failure and for the guidance of fluid, inotropes and vasoactive cardiovascular therapy.

**The Uscom BP+:** A supra-systolic oscillometric central blood pressure monitor which measures blood pressure and blood pressure waveforms at the heart, as well as in the arm, information only previously available using invasive cardiac catheterisation. The Uscom BP+ replaces conventional and more widespread sub-systolic blood pressure monitors, and is the emerging standard of care measurement in hypertension, heart failure and vascular health. The Uscom BP+ provides a highly accurate and repeatable measurement of central and brachial blood pressure and pulse pressure waveforms using a familiar upper arm cuff. The BP+ is simple to use and requires no complex training with applications in hypertension and pre-eclampsia, heart failure, intensive care, general practice and home care. The Uscom BP+ is supported by the proprietary

**BP+ Reporter,** an innovative stand alone software solution that provides a digital platform to archive patient examinations and images, trend measure progress over time, analyse pulse pressure waves and generate summary reports.

**Uscom SpiroSonic digital multi-path ultrasonic spirometers:** High fidelity, digital, pulmonary function testing devices based on multi path ultrasound technology. They require no calibration, are simple to disinfect, and are simple and accurate to use providing research quality pulmonary function testing in small hand held devices that can be used in research, clinical and home care environments. The devices can be coupled with mobile phone apps and proprietary SpiroSonic software, **SpiroReporter**, with wireless interfacing to provide remote tele-monitoring of pulmonary disease. The devices are specialised for assessment of COPD, sleep disordered breathing, asthma, industrial lung disease and monitoring of pulmonary therapeutic compliance.

**VENTITEST** digital ultrasonic ventilator testing solution is a new system for testing ventilators. All ventilators require calibration to maintain the accuracy with which they measure the pressure, flow and volume of air they deliver. VENTITEST and VENTITEST-S, based on advanced SpiroSonic technology provides a testing solution that provides for simple and accurate testing, archiving, analysis and reporting to optimise ventilation performance.
