**Nearmap Ltd (ASX: NEA) – Request for trading halt**

Pursuant to ASX Listing Rule 17.1, Nearmap Ltd ACN 083 702 907 (Company) requests an immediate trading halt be granted by ASX in respect of its ordinary shares.

The trading halt is requested in relation to potential legal proceedings. In accordance with ASX Listing Rule 17.1, the Company provides the following information:

1. **Reason for trading halt** – the trading halt is requested to allow the Company to respond to the potential legal proceedings.
2. **Duration of the trading halt** – the Company anticipates that the trading halt will remain in place until the earlier of such time as it makes an announcement to the market in relation to the potential legal proceedings and the commencement of trading on Friday, 7 May 2021.
3. **Termination of the trading halt** – the Company anticipates that the trading halt will cease upon it making the abovementioned announcement.
4. **No reason** – the Company is not aware of any reason why the trading halt should not be granted.
5. **Further information** – the Company is not aware of any other information to inform the market about the trading halt.
