## Share Issue on Performance Rights Exercise

Redflex Holdings Limited (**ASX:RDF**) refers to the shareholders' approval of the Scheme of Arrangement which was obtained earlier this week and the Second Court Hearing approval that was obtained earlier today.

As contemplated by the Scheme Booklet, 3,809,846 Performance Rights have vested as a consequence of the shareholders' approval.

These Performance Rights have now been exercised by the various executives which are the holders of them, including Group CEO and Managing Director, Mark Talbot.

Accordingly, the Company has issued 3,809,846 fully paid ordinary shares in this regard.

An Appendix 2A in relation to the executives' shares, and an Appendix 3Y in relation to Mr Talbot's shares, are being lodged simultaneously with this announcement.

This shares issue has been made without disclosure under the fundraising provisions of Part 6D.2 of the *Corporations Act 2001* (Cth) and this notice is being given pursuant to Section 708A(5)(e) of the *Corporations Act*. As at the date of this notice the Company has complied with its financial reporting and auditing obligations under chapter 2M of the *Corporations Act* and its continuous disclosure obligations under Section 674 of the *Corporations Act*.
