#### Completion of Placement – Tranche 2

Australis Oil & Gas Limited (**Australis** or the **Company**) (ASX:ATS) is pleased to announce it has completed the placement of 13.5 million new ordinary fully paid shares to the Directors of Australis at an issue price of A\$0.05 per share to raise up to A\$0.675 million (**Tranche 2**) as announced on 1 March 2021 and as approved at the ATS Annual General Meeting held on 11 May 2021.

The new shares issued under Tranche 2 will commence trading on 24 May 2021.

Net proceeds from the Placement have or will be used to:

- recommence leasing of TMS Core Area mineral rights; and
- general working capital purposes, including but not limited to, balance sheet support to:
  - o aid any negotiations with potential partners;
  - provide additional capacity to accelerate existing debt repayments, if desirable to do so at the relevant time (there is no obligation nor any intention to accelerate existing debt repayments);
  - o pay the costs of the offer.
