

**ASX Release | ClearVue Technologies Limited (ASX: CPV)**

**Notice Under Section 708A(5)(e) of the Corporations Act**

On 17 June 2021, ClearVue Technologies Limited (ASX:CPV) (*ClearVue* or the *Company*) issued a total of 5,337,500 fully paid ordinary shares on exercise of 5,337,500 unlisted options over shares, each option exercisable at \$0.25, expiring on 21 June 2021.

The issue of shares was under an exception to the Company's Listing Rule 7.1 capacity.

The shares issued under this announcement have been without disclosure to investors under section 708A(5) of the Corporations Act 2001 (Cth) (*Corporations Act*).
