Request for Trading Halt

Pursuant to ASX Listing Rule 17.1, Geopacific Resources Ltd (**Geopacific** or **Company**) requests a trading halt in respect of Geopacific's ordinary shares from commencement of trading on Thursday 24 June 2021.

Background

Geopacific has previously advised the market on 6 October 2020 (and subsequently in Quarterly Activities Reports) of the Project Finance Facility and Gold Stream Agreements being negotiated with Sprott Private Resource Lending II (Co), Inc. These negotiations have now concluded and a trading halt is requested to finalise binding documentation.

Trading Halt Request

In accordance with Listing Rule 17.1, Geopacific advises:

- (a) the trading halt is requested pending an announcement on the finalisation of the project financing for the Woodlark Gold Project (Market Announcement);
- (b) Geopacific wishes the trading halt to remain in place until the earlier of such time as it makes a Market Announcement, or the commencement of trading on Monday 28 June 2021; and
- (c) Geopacific is not aware of any reason why the trading halt should not be granted, or of any other information necessary to inform the market or ASX about the trading halt.
