Harris Technology sets another new Amazon Prime Day sales record

Online marketplaces continue to grow as the convenient alternative to shopping centres, so we look forward to further growth alongside Amazon Australia which is emerging as one of the national destinations of choice for online shopping."

Harris Technology has been adding products and categories on the Amazon Australia marketplace as part of its expansion strategy beyond the IT category, and into Gaming and Home Appliances categories. With over 2,000 products listed on Amazon, Harris Technology benefited from substantial marketing expenditure employed by Amazon across Australian media over the past week, driving traffic to the platform for Prime Day.

Harris Technology's rising sales have been assisted by Amazon's growing profile in the Australian retail industry, driving sales momentum for Harris Technology which reported end of March YTD revenue of \$30M (unaudited) - 300% Year-on-Year growth.

In the past 12 months, Harris Technology has received more than 4,750 individual customer reviews on Amazon Australia with 100% being positive [1]. To achieve this with the number of sales processed enhances Harris Technology's profile and enables it to maintain its position as the Number 1 ranked seller on the marketplace [2].
