# RECORD NICKEL SULPHIDE INTERCEPT AT JAGUAR: 56.1m at 2.05% NICKEL INCLUDING 17.6m at 4.86% NICKEL

Expansionary drilling continues to gain momentum, delivering best project intercept seen to-date

- Drilling at the Jaguar South Deposit returns multiple thick and consistent high-grade nickel sulphide intersections, including the best drill intersection seen at the Jaguar Project to-date:
  - ➤ Hole JAG-DD-21-151:
    - o <u>56.1m at 2.05% Ni</u> from 206.0m, including:
      - 17.6m at 4.86% Ni from 208.0m; and
      - 6.7m at 2.09% Ni from 255.4m
  - ➤ Hole JAG-DD-21-143:
    - o 7.2m at 2.36% Ni 133.5m, including:
      - 3.3m at 3.46% Ni from 135.0m
    - 12.6m at 1.25% Ni from 173.4m, including
      - 5.8m at 2.01% Ni from 176.7m

Strike extension drilling at Jaguar Central highlights a likely extension of the Resource limits at least a further 60m to the east, with first results and visuals confirming the continuation of the Jaguar Central high-grade shoot:

- ➤ Hole JAG-DD-21-148:
  - o 4.5m at 1.22% Ni from 239.5m
  - o **10.0m at 0.99% Ni** from 267.0m, including:
    - 5.0m at 1.30% Ni from 272.0m

In-fill drilling at the Jaguar West and Central North deposits continues to highlight the consistency of mineralisation in the deposits and the robust nature of the existing Resource model:

- ➤ Hole JAG-DD-21-140:
  - o **13.2m at 1.63% Ni** from 64.0m, including:
    - 9.2m at 2.10% Ni from 66.8m
  - o 6.8m at 1.24% Ni from 114.2m
  - o 4.2m at 1.28% Ni from 154.5m
- Hole JAG-DD-21-136:
  - o **4.0m at 1.63% Ni** from 48.0m
  - o 10.8m at 0.79% Ni from 76.0m
- Hole JAG-DD-21-150:
  - o 30.9m at 0.60% Ni from 202.2m
- Five diamond rigs on site drilling double-shift, with two additional rigs expected to arrive by mid-July.

  One RC rig is on site drilling the Leão Prospect, the first of an extensive pipeline of greenfields targets.
- Strong cash position of A\$21 million to drive ongoing drilling and DFS activities.



Centaurus Metals (ASX Code: **CTM**) is pleased to advise that ongoing Resource development and extensional drilling at its 100%-owned **Jaguar Nickel Sulphide Project** in the Carajás Mineral Province of northern Brazil has delivered the best drill intersection from the project to date. Drill hole JAG-DD-21-151 intersected **56.1m at 2.05% Ni** from 206.0m, including **17.6m at 4.86% Ni** from 208m (Figure 1), immediately below the current planned open pit limits.

Centaurus' Managing Director, Mr Darren Gordon, said the record intersection from drill hole JAG-DD-21-151 demonstrated the enormous growth potential of the Jaguar Project, with the current phase of step-out drilling and regional exploration still in its early stages.

"It's pretty remarkable to be able to report our best intercept to date – a stunning **56.1m at 2.05% Ni** including **17.6m at 4.86% Ni** – even after drilling over 300 holes into the Project and delivering a globally significant resource of more than 560,000 tonnes of contained nickel. The key message for investors is that this is a project that is continuing to grow – and grow quickly, both from resource development drilling and step-out and regional exploration.

"The new record intercept at Jaguar South has to be one of the best nickel sulphide hits in the world this year and to have this sort of intersection immediately below our planned pit limits indicates how much upside remains in the Project.

Within the next couple of weeks, we will have eight rigs on site and this expanded capacity will allow us to work on resource growth and greenfields drilling in conjunction with the development drilling. This multi-pronged approach sets us up for what should be a big second half of project growth at Jaguar.

"Jaguar is already a standout project in terms of scale and quality amongst undeveloped nickel sulphide projects worldwide and at the planned nickel production rate of +20,000tpa, Centaurus will become a global Top 10 nickel sulphide producer. The fact that Jaguar stands to grow a lot more can only further enhance its credentials as a potential source of clean, low-emission nickel sulphides to meet surging global demand as the world moves rapidly to embrace electrification and decarbonisation."




Figure 2 – The Jaguar March 2021 MRE Resource

In March 2021, the Company delivered an updated JORC 2012 Indicated and Inferred Mineral Resource Estimate (MRE)<sup>1</sup> for the Jaguar Project totalling **58.9Mt at 0.96% Ni for 562,600 tonnes of contained nickel** (see Figure 2 below and Table 4 for details on the March 2021 MRE).


#### **Jaguar South Deposit**

Jaguar South is currently the biggest deposit at the Jaguar Project, hosting a Mineral Resource of **18.7Mt at 0.97%**Ni for more than **180kt of contained nickel**, including an Indicated component of **7.4Mt at 1.19%** Ni for **87kt of contained nickel**.

Hosted in a mylonitised sub-volcanic porphyritic dacite, Jaguar South extends over a strike length of more than 650m and comprises continuous sub-vertical veins and semi-massive to massive breccia zones that can be up to 20m wide and extend from surface to more than 300m depth. The mineralisation remains open at depth and along strike in both directions (Figure 3 and Figure 8).

Drill-hole JAG-DD-21-151, completed on section 478040mE at Jaguar South (Figure 3) as part of the resource development in-fill program, has now returned the **best interval from the project to date, intersecting 56.1m at 2.05% Ni including 17.6m at 4.86% Ni.** This intersection is located immediately below the current pit limits and the grade and thickness has outstanding potential to push the current open pit design even deeper.

Additional in-fill drilling on section 477885mE, located 155m to the west, has intersected more shallow, high-grade mineralisation including **7.2m at 2.36% Ni** from 133.5m and **12.6m at 1.25% Ni** from 173.4m in hole JAG-DD-21-143, demonstrating the consistent nature of the mineralisation at Jaguar South (Figure 3).

The recent outcomes from the Value-Add Scoping Study for the Jaguar Project have also demonstrated that the mineralisation below the current pit limits is technically and economically feasible for underground operations.


In light of this, the Company has been actively advancing its step-out drill program at key deposits such as Jaguar South in parallel with resource development drilling.

Drill-hole JAG-DD-21-164 (on section 478210mE (Figure 4), located 170m to the east of JAG-DD-21-151), has delivered a further impressive visual result, demonstrating that the strong mineralisation continues both along strike and at depth.

JAG-DD-21-164 is the deepest drill hole Centaurus has completed to date (544m) and has intersected 12.7m of semi-massive and massive sulphides (Figure 6 and Table 2) within a broader +40m zone located more than 60m below the Company's previous deepest hole on that section, JAG-DD-20-112, which intersected 10.5m at 1.75% Ni from 346.5m, including 6.0m at 2.16% Ni from 347.3m down-hole.

Step-out drilling at Jaguar South has consistently intersected the mineralised domains in line with the EM conductor plates, current geological model interpretations and the developing structural model. This bodes well for deeper drilling that is planned both to identify additional Resource tonnes as well as upgrade existing underground Resources into the higher-confidence Resource categories required for future Ore Reserve Estimation and DFS work.

#### The Jaguar Central Deposit

The Jaguar Central Deposit is the second biggest deposit at the Jaguar Project, with a current Resource of **10.2Mt** at **1.00% Ni** for more than **100kt of contained nickel**, including an Indicated component of **8.4Mt at 0.99% Ni** for **83kt of contained nickel**. Consistent positive results from recent step-out drilling indicate strong potential to grow this Resource.

The Central Deposit is hosted in a sub-volcanic porphyritic dacite and features a high-grade ore shoot that starts at surface at the western end of the deposit and plunges sub-horizontally to the east across 10 drill sections and now has more than 550m of continuous strike after the recent successful strike extension drilling.




Figure 5 - The Jaguar Central Deposit: Cross-Section 477080mE (left) and 477290mE (right).

Nickel grades previously reported within the high-grade shoot are consistently over 1.0% nickel<sup>2</sup> with outstanding continuous down-hole intersections such as **30.8m at 3.30% Ni** (JAG-DD-20-104 – see Figure 5), **33.7m at 2.23% Ni** (JAG-DD-20-056), **31.4m at 2.47% Ni** (PKS-JAGU-DH00030) and recent hole JAG-DD-21-142 on section 477180mE, which intersected **64.9m at 1.07% Ni** from 216.5m, just 30m below the current pit limits.

Importantly, recent hole JAG-DD-21-148, located on section 477290mE, intersected multiple mineralised zones including **10.0m at 0.99% Ni** from 267.0m (Figure 5). This section is a resource extension section, 60m east of the previously easternmost section of the Jaguar Central Deposit, **adding 60m of along-strike extension to the Jaguar Central Deposit.**

It is interpreted that JAG-DD-21-148 intersected the top portion of the high-grade shoot and, importantly, recently completed drill hole, JAG-DD-21-152, has intersected the shoot again a further 40m down-dip from JAG-DD-21-148 (Figure 5), demonstrating the continuity of the shoot. Additional down-dip drilling is planned as well as further drilling down-plunge and along strike to the east, where the shoot remains open.




Figure 9 - The Jaguar Central Deposit with DHEM conductor plates (blue) overlaid on the Ground Magnetics Survey (RTP)

Highlights of new assay results from the step-out drilling at the Jaguar Central Deposit include the following downhole intervals (see Table 1 for complete results, plan map in Figure 9 and sections in Figure 5):

- **10.0m at 0.99% Ni,** 0.05% Zn, 0.03% Cu and 0.05% Co from 267.0m, including:
  - 5.0m at 1.30% Ni, 0.05% Zn, 0.04% Cu and 0.05% Co from 272.0m
- 2.0m at 0.66% Ni, 0.03% Zn, 0.02% Cu and 0.02% Co from 327.0m
- > 5.5m at 0.52% Ni, 0.04% Zn, 0.02% Cu and 0.01% Co from 332.0m

Importantly, the recently completed Value-Add Scoping Study demonstrated that underground operations are viable at the Jaguar Central Deposit. These new step-out drilling results from the easterly plunge of the high-grade shoot are not included in the March 2021 MRE and have consistently intersected thick zones of high-grade mineralisation with the potential to either extend the planned open pit at depth and/or establish additional Resources for the future underground operations.



The mineralisation remains open at depth, along the entire strike of the deposit and down-plunge to the east, where additional drilling is planned to further extend the strike beyond current resource limits.

#### **Jaguar West & Jaguar Central North Deposits**






Figure 10 - The Jaguar West Deposit with DHEM conductor plates (blue) overlaid on the Ground Magnetics Survey (RTP)




Figure 11 – The Jaguar Central North Deposit with DHEM conductor plates (blue) overlaid on the Ground Magnetics Survey (RTP)

Currently the Jaguar West and Jaguar Central North Deposits host Inferred Resources only, as historical drilling was broadly spaced and often shallow. The Company's first drilling campaign at both deposits has been very successful in confirming the current geological model, as well as identifying additional higher-grade zones within the broader mineralised envelope (Figures 10 and 11).

New structural and geophysical targets have been identified at both deposits along strike and down-dip, where the deposits remain open. A rig remains dedicated to each of the Jaguar West and Jaguar Central North Deposits. Most of the in-fill drilling for the open pits is now complete and step-out drilling has commenced to expand the Resources.

Highlights of new assay results from in-fill drilling at the <u>Jaguar West Deposit</u> include the following down-hole intervals (see Table 1 for complete results, plan map in Figure 10):

The results from the Jaguar West and Jaguar Central North Deposit holes outlined above will form part of the next planned JORC MRE upgrade, which is expected to be delivered in Q4 2021.

#### **Additional Diamond Rigs**

Five diamond rigs are now on site operating on double-shift. A further two rigs have been contracted, with mobilisation of the rigs, support vehicles and drill teams expected to take place over the next 2-3 weeks. All new contractors must undergo the appropriate testing and isolation procedures under the Company's COVID-19 Management Plan before they enter site.






