# MAJOR UNDERGROUND DRILLING PROGRAM UNDERWAY AT "GOLDEN MILE" WITH MASSIVE SULPHIDES INTERSECTED IN SECOND HOLE

Estimated high-tenor massive sulphide intersection demonstrates proof-of-concept and highlights the significant discovery opportunity in the gap between Long and Durkin North

Mincor Resources NL (**ASX: MCR, "Mincor"** or **"the Company"**) is pleased to advise that it has made a strong start to its underground drilling program in the untested 1.1km zone between the Long and Durkin North mines near Kambalda, with the second drill-hole intersecting a zone of high-tenor massive sulphides.




Figure 1. Indicative image of drilling program and location of intersection

A major program of underground drilling commenced recently from the first identified stockpile location in the space between the Long and Durkin North orebodies, referred to as the "Golden Mile" of nickel in Mincor presentations (see Figure 1).

The program will comprise sequential "fans" of underground diamond drill holes which, in conjunction with down-hole electromagnetics (DHEM), will systematically test this zone for significant new zones of nickel sulphide mineralisation.

In an excellent start to this program for FY22, the second diamond hole has yielded an exciting massive sulphide intersection which demonstrates the typical high-grade tenor associated with the Kambalda Dome mines of Long and Otter Juan.




Figure 2. Image of intersection from ULG-21-016 with massive sulphides

The estimated width of the intersection is 0.5 metres and, while portable-XRF analysis has confirmed the high-grade tenor, given this is based solely on a visible inspection and consistent with Mincor standards the Company will await final assays to confirm the average nickel grade of the intersection. Assay results are expected within 1-2 weeks (see Figure 2).

Mincor's Managing Director, David Southam, said: "This is a fantastic start to what is a significant underground drilling campaign for FY22 in the untested space which we have previously described as the 'Golden Mile' of Nickel between Long and Durkin North.

"Webdrill commenced drilling this month and achieving a massive sulphide intersection in just our second hole has certainly exceeded our expectations and bodes well as drilling activity ramps up with a second rig due this quarter. Commencing from late August, a systematic down-hole EM program will also be undertaken and today's intersection will be the first hole in that program to be surveyed.

"While it's still early days in our FY22 drilling program, it is worth remembering that one of the core reasons for securing the Long nickel assets was to provide access to the significant search space, or gap, between the Long and Durkin North orebodies. Mincor was the first company to consolidate ownership of the Northern Kambalda Dome since WMC Resources owned these assets decades ago. Mincor's thesis has been that there is a discovery opportunity in the 'Golden Mile' space given the lack of historical drilling in the region. In essence, today's announcement confirms that proof-of-concept of the potential opportunity for our shareholders.

"With Mincor now well advanced with underground development linking the Long and Durkin North orebodies, drilling will be undertaken from the various stockpile locations on the Durkin Incline, with this intersection occurring in the first stockpile location selected for the program."



Mincor awarded the underground drilling contract to Webdrill in the March 2021 Quarter and mobilisation to site was completed in late June/early July 2021. The second underground drilling rig is currently completing a small grade control program. Once completed later this quarter, that rig will be utilised for the exploration program.

A permanent wire for down-hole EM ("DHEM") will be delivered to site in August 2021, meaning that an active DHEM program can be efficiently completed. In general, DHEM will be conducted on every second hole to assist with targeting for the drilling program as it progresses sequentially across the "Golden Mile" (Figure 1).
