### **Jervois Mining Limited – Request for voluntary suspension**

Jervois Mining Limited (ASX: JRV) (**Company**) refers to the trading halt granted in respect of its ordinary shares on Monday, 19 July 2021 and requests a voluntary suspension of its securities with immediate effect.

In accordance with ASX Listing Rule 17.2, the Company provides the following information:

1. The voluntary suspension is requested to allow the Company to continue to assess the material acquisition and associated equity raising that gave rise to the trading halt.
2. The Company requests that the voluntary suspension continue until the earlier of the Company releasing an announcement in relation to the acquisition and associated equity raising and requesting that ASX end the suspension, or the commencement of trading on Wednesday, 28 July 2021.
3. The Company expects that the voluntary suspension will be ended by it making an announcement on the ASX in relation to the acquisition and the associated equity raising and requesting that ASX end the suspension.
4. The Company is not aware of any reason why the voluntary suspension should not be granted.
5. The Company is not aware of any other information necessary to inform the market about its suspension at this time.
