Monthly and Quarterly Appendix 4C – June 2021

Further to ASX's request, pursuant to listing rules 18.7 and 18.8, that Oliver's Real Food Limited ("OLI" or the "Company") lodge a monthly and quarterly report in the form of an Appendix 4C under listing rule 4.7B, commencing with an Appendix 4C for June and Appendix 4C for the quarter ended June 2021, the Company provides both Appendix 4C for the month ending 30 June 2021.

The Company's material business activities for June 2021 included:

- Company-store sales \$1,696,000, down 21.71% on <u>2019 sales</u>
- State performance compared with <u>2019</u>: NSW down 11.44%, VIC down 53.27%, QLD up 5.24%
- Revenue loss due to Victorian 4.0 lockdown between 1 June to 10 June estimated at \$220,000.
- NSW stores sales were on track to match 2019, but Sydney lockdown and travel restriction from 24 June onwards immediately impacted sales.
- NSW lockdown and travel restrictions and Victoria 5.0 lockdown impacting July revenue significantly. As previously announced, most Company-owned stores have been closed during July.
- Oliver's Food to Go sales were \$349,000 and four more EG service stations were added, bringing a total to 153 stations as of June 2021.
- Restructuring completed.
- Significant one-off restructuring costs incurred during the month.

The Company further reports that the expenditure of \$65,000, in the Quarterly 4C, to related parties reported at Item 6.1 is solely Directors' fees paid to Non-Executive Directors.
