# **US & AUSTRALIA ACCREDITATIONS UPDATE**

VIP Gloves Limited **(VIP or the Company)** is pleased to provide an update regarding accreditations of its nitrile glove product to the key markets of United States of America (USA) and Australia.

#### FDA

Following receipt of the provisional US Food and Drugs Administration's 510(k) Medical Product License approval in Q2 2021, which provides for the potential to ship and market medical examination nitrile gloves into the USA In late July 2021, VIP Gloves successfully completed the US agent information registration with the FDA Industry Systems and in recent days received confirmation that it has met all the procedural requirements allowing the Company to proceed with marketing its product in the highly lucrative US market.

# TGA

The Company has also recently lodged its application with the Australian Therapeutic Goods Administration (TGA) to market its nitrile gloves in Australia. VIP will provide the market with an update once accreditation has been received.

Significant efforts are underway to make inroads into these new markets that will enable VIP to expand its geographical reach to become a global glove supplier, in addition to providing a platform to launch its house brands, and support the additional production capacity coming onstream from Lines 7 and 8 and the second factory.

To date, VIP has commenced selling nitrile gloves to buyers who are shipping into the European and UK markets under the CE EU Examination Certificate issued to VIP in January 2021 for the distribution of nitrile gloves throughout the European Union.

This announcement has been approved by the Board of VIP Gloves Limited.
